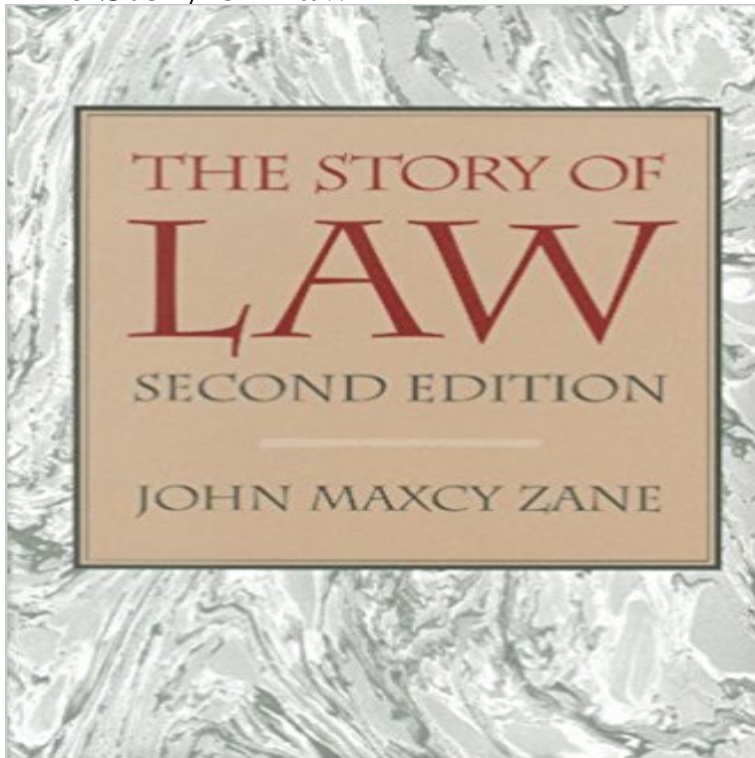


The Story of Law
