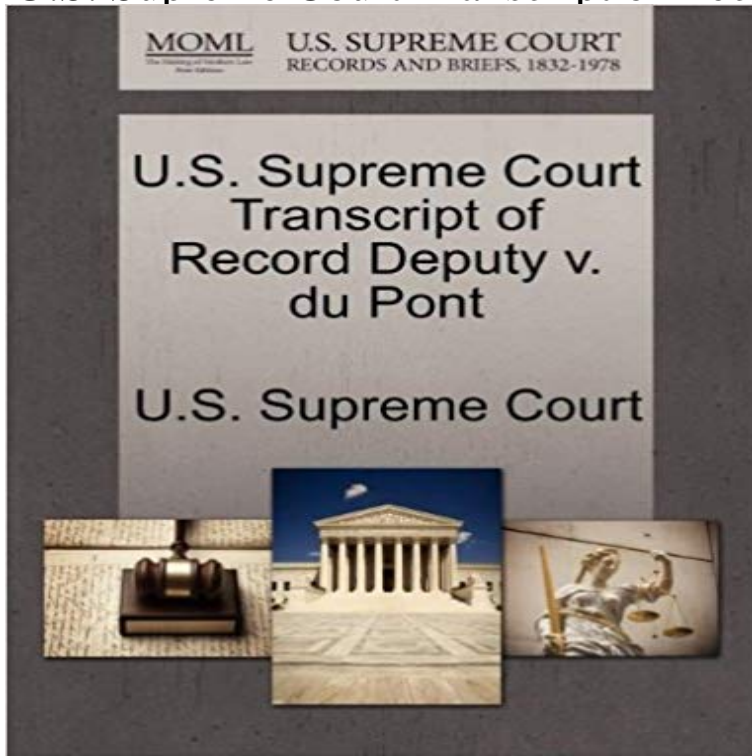

is currently 4.74%. Rachel Springall, finance expert at Moneyfacts, said: "It's fantastic to see such low rates on offer

borrowers. "Those looking for more flexibility over the shorter term may prefer a discounted deal, but those looking for
some security could choose the fixed rate. "In such a low interest rate environment it would be ideal for borrowers to
