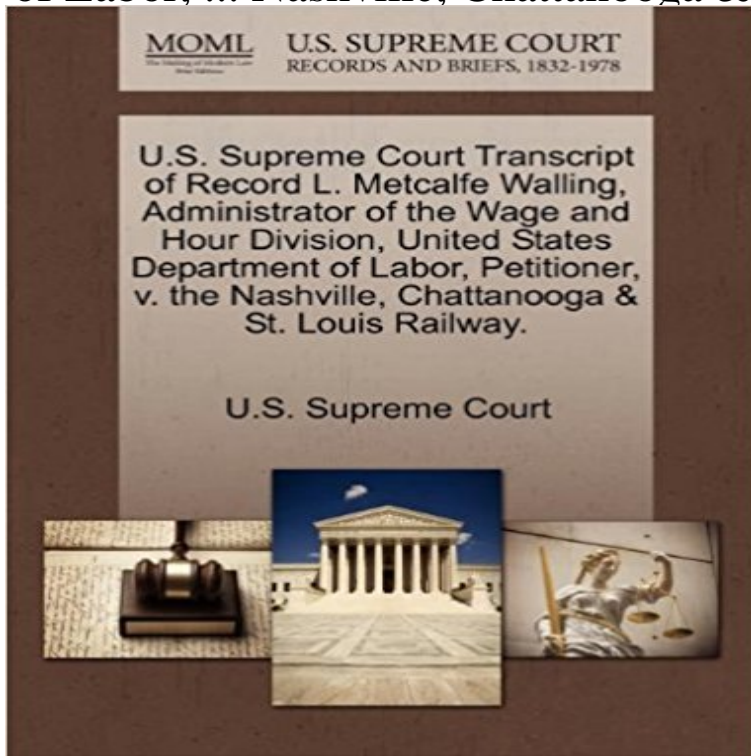

Rachel Springall, finance expert at Moneyfacts, said: "It's fantastic to see such low rates on offer from Yorkshire Building Society and the choice between variable or fixed deal will appeal to different types of borrowers. "Those looking for more flexibility over the shorter term may prefer a discounted deal, but those looking for some security could choose the fixed rate. "In such a low interest rate environment it would be ideal for borrowers to

consider overpaying their mortgage.
