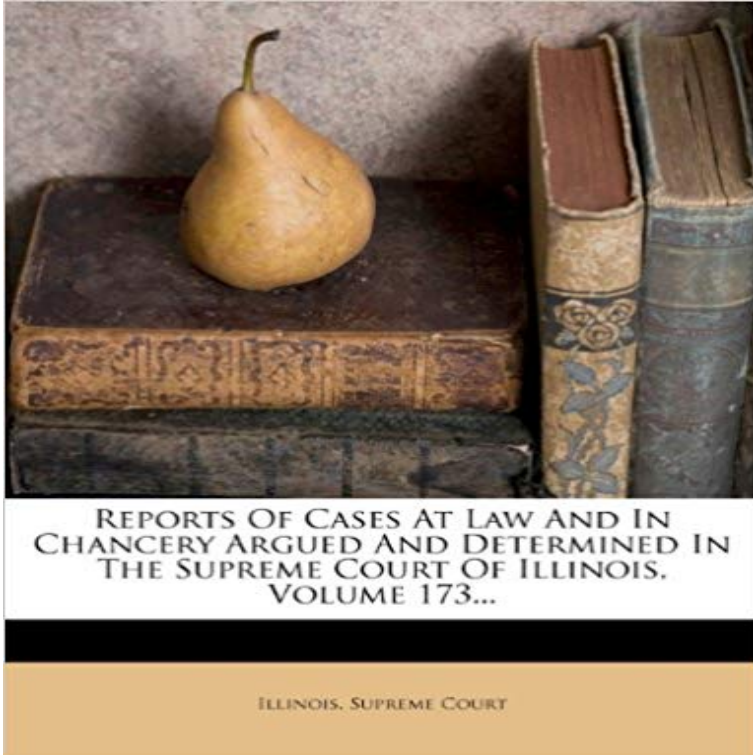

is currently 4.74%. Rachel Springall, finance expert at Moneyfacts, said: "It's fantastic to see such low rates on offer
