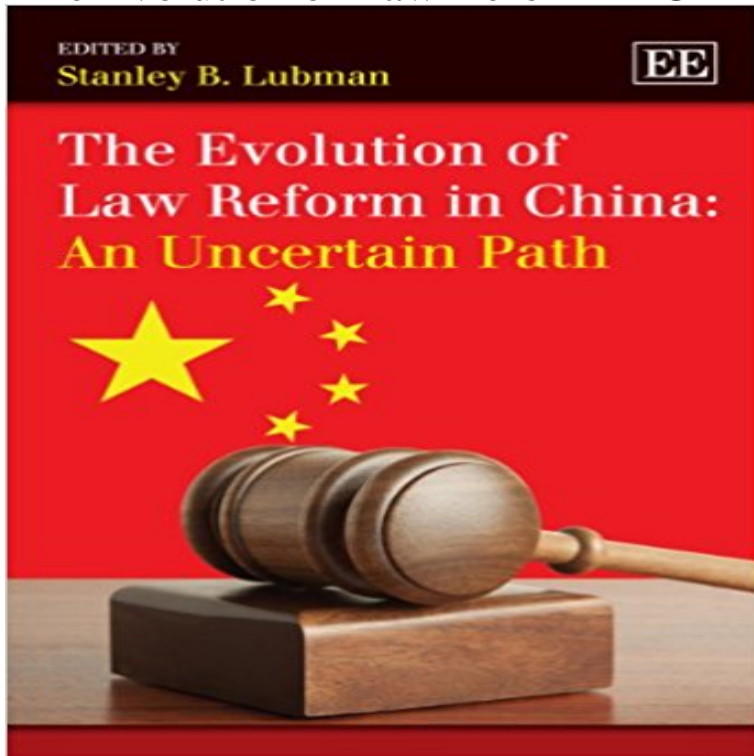


The Evolution of Law Reform in China: An Uncertain Path (Elgar Mini)

some security could choose the fixed rate. "In such a low interest rate environment it would be ideal for borrowers to
