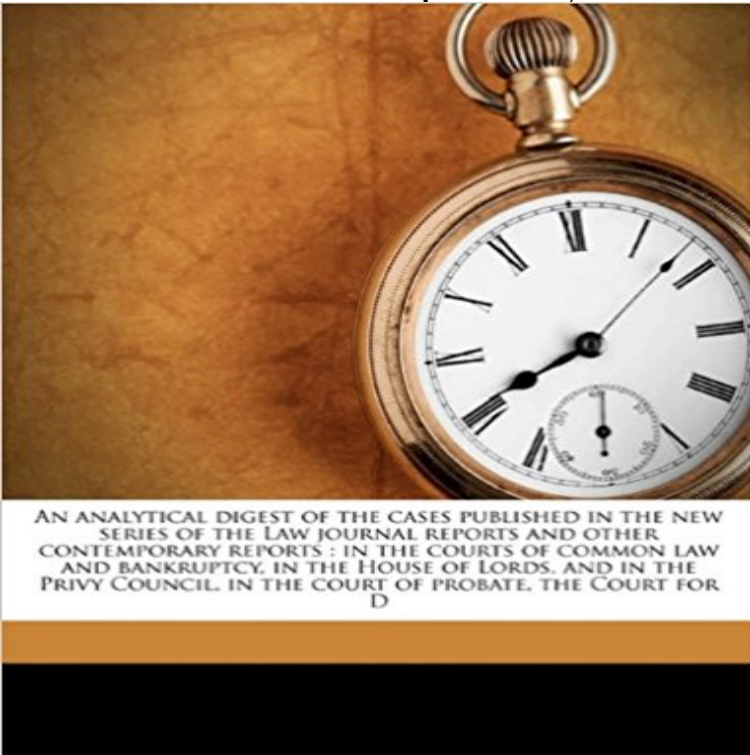

The product comes with a £1,495 fee, though the society also offers a £995 fee option at 1.05%. James Farrow, senior mortgage manager at Yorkshire Building Society, said: "We are very pleased to offer borrowers the lowest mortgage rate ever available. "The cost of funding has fallen in recent weeks and as a financially strong building society with no external shareholders to satisfy we have the ability to pass this on to borrowers." After the 2-year period the mortgage will revert to the lender's standard variable rate, which is currently 4.74%.
